IV. It is hereby understood that if The Client cancels the event, in writing:

1. Within three (3) days after this agreement is signed, the full (100%) reservation fee will be refund.
2. More than sixty (60) days prior to the event, half (50%) of the reservation fee will be refund.
3. Sixty (60) days or less prior to the above event date, The Client gives up all rights to said reservation fee.

V. It is further understood that the event date will be reserved only upon payment of the reservation fee by The Client.

VI. FURTHER INSTRUCTIONS OF THE EXPRESS:

1. A reasonably secure stage area with easy access.
2. Stage area to be located within 15 feet of an AC outlet.
3. If any other effects are to be used, (i.e. lights, lasers, etc.), a second outlet, on a different circuit, will be required, also within 15 feet of the stage area.

VII. The EXPRESS will not be held responsible for any acts beyond their control,

VIII. The EXPRESS reserves the right to stop any event if any guest is behaving in a manner that puts The EXPRESS or any guest in a position of possible injury.

IX. In order to prevent liability resulting from an accidental injury to an individual attending this event, The EXPRESS reserves the right to deny any guest access to the sound system, music or equipment owned or leased by The EXPRESS.

- The Express will provide Professional Audio Equipment - Minimum Equipment to be Included:
 - 1 Wireless Microphone
 - 1 Wired Microphone
 - 1 DJ Controller and/or Mixer
 - 1 Laptop with Pro DJ software
 - 2 15" 2-way Pro DJ Speakers and/or Bose L1 System
 - Audio Amplification Sufficient for Room Size

Additional Equipment or Services (Must be initialed by BOTH parties):

It is understood and agreed that all the foregoing agreements shall be strictly construed, and that any violation thereof by any person authorized to represent The Client shall constitute a breach of this agreement and require a forfeiture of the above stated event, and a forfeiture of any monies paid to The EXPRESS for the stated event.
